I. INTRODUCTION

A successful secondary school program that seeks to group and regroup pupils according to their developing abilities and interests, that capitalizes upon and grows out of the work the pupil has done in the elementary school, and that hopes to join forces with the family in projecting appropriate vocational and academic goals will require a strong guidance program. The pupil personnel services at Thomas Jefferson Junior High School, therefore, were reorganized to better reflect such a philosophy of the school.

The school is attended by boys and girls whose ages range from eleven to fifteen. They are grouped according to a nongraded continuous progress schedule whereby each student is involved in a program where he actually savors the benefits of continuous progress. He is the baseline and the only yardstick against which his true accomplishment is measured. He starts at his own performance level and continues to work with no ceilings on learning imposed by the school.

Many evaluations of pupil personnel services have been conducted throughout the country. The researcher finds that most of these evaluations, however, have involved administrators, teachers, pupil personnel workers, parents and

college professors. Few have actually asked the recipients themselves to evaluate the services.

Taking the approach of surveying the recipients of the guidance services, the researcher proposed to determine whether or not the pupil personnel services at Thomas

Jefferson Junior High School were meeting the needs of the students according to the students' standards. The conclusions drawn from this study will hopefully influence future planning and alterations of the pupil personnel services at Thomas Jefferson Junior High School. The researcher sought to answer the following questions:

- Do the students of Thomas Jefferson Junior High School understand, use, and benefit from the individual guidance and counseling services that are available to them?
- 2. Do the students of Thomas Jefferson Junior High School understand, use, and benefit from the group guidance and counseling services that are available to them?
- 3. Do the students of Thomas Jefferson Junior High School understand, use, and benefit from the services of the school nurse?
- 4. Do the students of Thomas Jefferson Junior High
 School understand, use, and benefit from the services
 of the school psychologist?

5. Do the students of Thomas Jefferson Junior High
School understand, use, and benefit from the services of the visiting teacher?

II. REVIEW OF THE LITERATURE

There have been several large scale investigations of pupil personnel services conducted in the past decade. One, undertaken by Campbell, sought to describe "the present status of Pupil Personnel Services in public secondary schools . . . and to compare the viewpoints of school administrators, counselors, teachers, students and parents on guidance issues." Questionnaires were mailed to a representative group of 738 high schools of all types. Each cooperating principal was asked to distribute questions to one counselor, five teachers, five parents, and ten students. The schools were divided into three categories -- academic, comprehensive, or vocational. They were also classified as rural or urban. Replies were received from 353 schools. Campbell's findings revealed that how counselors spent their time depended largely on the type and location of the school. He found that students in all types of schools agreed that aid in choosing an occupation was the most important service. He also found that the availability of guidance services far

exceeded their use even in schools where students indicated a favorable attitude toward guidance. Although counselors in every type of school spent the largest block of their time in individual counseling, they generally agreed that the time thus spent was insufficient. In a large number of schools the needs of prevocational students were neglected; less than one-quarter of all counselors concentrated on serving this group.

Expectations varied greatly for pupil personnel services among different groups--pupils, parents, teachers, and administrators. Campbell concluded that "if guidance programs are to be effective in meeting service needs with limited resources, they must be designed systematically and realistically to achieve a set of clearly stated objectives selected from a much larger set of possible objectives."

Another study, in 1960, bearing the name Project Talent, also sought to learn about the state of pupil personnel services in American high schools. The findings indicated that a significant minority of schools, 27 per cent, had no regularly assigned staff member whose principal function was guidance; the proportion of trained counselors was small; the major activities in which counselors engaged were test administration, course selection, and college advising,

with a heavy bias in the direction of services to the college-bound.

Armor utilized data from the Coleman Report published by the United States Office of Education in the mid-1960's in connection with its large-scale inquiry into educational opportunity and supplemented them with findings from a questionnaire conducted in the Boston area. He found that there was a marked variation in student-counselor ratio among regions. The metropolitan areas of the Great Lakes reported a ratio of 1:481 in contrast to 1:695 in the Mid-Atlantic states. Variability in counseling utilization among regions, between urban and semi-rural settings, and from school to school was a matter of concern to Armor, who believed that the key to the "institutionalization of the program and its proposed commitment to students was the average percentage of time counselors devote to counseling students on an individual basis."

Armor did not justify the criterion of individual counseling, nor did he prove its effectiveness. In fact, he himself presented data from several upper-income schools in his Boston sample which indicated that students in these

schools still received most of their advice about colleges from their families. Nevertheless, he found that counselors saw more of such students than of others. He remarked that "the students who may require assistance most may be using the facilities least."

Taking an approach similar to Armor, Lister reviewed a group of research studies in order to acquire insight into the critical question of whether the school counselor facilitates and enriches "the personal development of the students with whom he works." He concluded that the research studies he reviewed related specifically to the counseling relationship and were not concerned with the effects of other pupil personnel services. He suggested that the equivocal responses to school counseling that have been reported may have been grounded in the realization that many counselors were not able to provide useful help.

A study of "total impact" sponsored by the United States Office of Education and the Minnesota Department of Education was concerned with evaluating the impact on outcomes of all inputs of the pupil personnel services. 7 The

investigators included not only the various activities performed by guidance counselors, but also all other measurable characteristics that might have affected outcomes. They sought, moreover, to take into account the ways in which factors in the school and external environment unrelated to guidance might also have influenced results. Conclusions of this study included the following: The best pupil personnel services tend to be in schools where they are least needed -that is, where the students have good ability, come from advantaged homes, and where the school climate encourages scholastic excellence; in schools with less able students and an anti-academic climate, counselors tended to spend more time on "problem students"; and the one guidance "input" that has an effect on hoped-for outcomes is the personality of the counselor as perceived by students and observers. The investigators contended that "the counselor as a human being, rather than any specified guidance function he performs, affects the lives of students most."8 Pupil personnel services contributed little, if anything, to stronger selfconcept. It was observed that "if anything, self-perception seemed better where there is less contact with counselors."9 There was no evidence that pupil personnel services helped to improve instructional deficiencies in schools where there was considerable underachievement, or to change unrealistic

vocational aspirations, or to contribute to the pursuit of continued training.

On the basis of their findings, the authors recommended that "counselors consider spending less time and effort with individual students in attempting to ameliorate problems brought about by negative influences in the school environment and more effort in doing what they can to bring about changes which will facilitate healthy growth." 10

Cicourel and Kitsuse investigated a high school located in a high-income suburban community in the midwest which had a total of twenty-two full-time and part-time counselors with a counselor-student ratio, ranging from 1:100 to 1:225. 11 The major thrust of the analysis and findings was that one cannot blithely assume that an improved ratio of counselors to students and corresponding improvements in counselors' training will necessarily benefit all students. They presented considerable material which suggested that children from low-income homes whose parents have had relatively little formal education are likely to be assessed and guided not in terms of their capacities, interests, or potential opportunities but in terms of the preconceptions and prejudices of the guidance personnel who tend to divide young people into the college-bound and the noncollege-bound according to their family background.

The investigation of the literature identified few studies in which the researchers had actually asked the students themselves to evaluate the pupil personnel services.

The absence of such studies reflected the need for an investigation in this area.

III. PROCEDURE

Definitions of Terms

For the purposes of the present study, the following definitions were used:

Pupil personnel services. -- The pupil personnel services are those services performed for the students by the counselors, school nurse, school psychologists and the visiting teacher at Thomas Jefferson Junior High School.

Nongraded continuous progress schedule.--A nongraded continuous progress schedule is a schedule achieved by students according to their own performance levels without regard to chronological age.

First year student. -- A first year student is one who has attended Thomas Jefferson Junior High School less than one full year.

Second year student. -- A second year student is one who has attended Thomas Jefferson Junior High School more than one year and less than two years.

Third year student. -- A third year student is one who has attended Thomas Jefferson Junior High School more than two years but less than three.

Sample

The sample of 212 students consisted of 20 per cent of the students from each year. It included seventy-three first year students, sixty-two second year students, and seventy-seven third year students. Fifty-one per cent of the sample were males and 49 per cent were females; 3 per cent were black and 97 per cent were white. The students were selected by means of a table of random numbers. 12

Instrument

The instrument was divided into two parts. Part I was a Personnel Data Sheet and Part II was the Questionnaire. 13

The questionnaire sheet was divided into four sections. The first dealt with those services performed by the counselor. This section included both group and individual counseling. Section two contained questions that pertained to the services of the school nurse. The third section contained questions related to the services of the school psychologist. The fourth section raised questions about the services of the visiting teacher. All four sections of the questionnaire assessed the understanding, use, and benefit of each of these persons. Table 1 describes the classification of questions according to number.

Methods of Collecting Data

The instrument was distributed to the students in four separate sessions which were held in the auditorium. One session was held for each one of the three levels and a final one was held for those students who had been absent. The sessions were held on November 16, 17, 18, and 19. The same brief explanation was given to each session. The students were told that the evaluation would be used to help the school determine if the pupil personnel services were meeting the needs of the students and where the strong and weak areas were. It was explained that no names would be necessary on

A maximum time of one hour was given for the completion of the evaluation. All students finished the evaluation in less than that amount of time.

Analysis of Data

The researcher tabulated the "yes" and "no" answers on the completed questionnaires and grouped them according to the number of years the students had been at Thomas Jefferson Junior High School, according to the sex of the student, and according to the race of the student. The responses were organized to correspond to the three broad areas of understanding, use, and benefit. Students had been asked to write one comment about one negative response for each pupil personnel member. A list of these negative comments was compiled for each position at each one of the three levels.

IV. RESULTS

In comparing the responses concerning the four pupil personnel members with respect to the length of time the pupils had been in attendance at Thomas Jefferson, it was found that the counselor ranked the highest in all three areas of understanding, use, and benefit. Ranking second in the same areas was the school nurse. The school psychologist ranked third in the area of understanding and fourth in the area of use and benefit. The visiting teacher ranked fourth

in the area of understanding and third in the area of use and second in benefit. Table 2 provides a summary of these results.

Table 3 was constructed from the results on the personnel data sheet when the sex of the pupils was the variable under consideration. When percentages were compared, it was found that in no case did the percentages vary more than 4 per cent and in most cases the variation was no more than 2 per cent.

Since the sample yielded only 3 per cent black students and 97 per cent white students, no comparisons were made between black and white students.

The students' responses to the question on the personnel data sheet that asked their intentions after high school, yielded few responses and those that did answer said they wanted to go to a four year college. The lack of response seemed to indicate that most of these students were not sure of their future plans.

V. DISCUSSION OF RESULTS

The school counselor ranked the highest in the areas of understanding, use and benefit. There are many probable

explanations for this: (1) there were four counselors in the school and the other three pupil personnel members reflect the work of only one member for each position; (2) the four counselors spent full time counseling at Thomas Jefferson Junior High School and the other pupil personnel members were shared with other schools; (3) counselors were more involved in curriculum planning and schedule advisement on a continuing basis than the other pupil personnel members; (4) the offices of the school counselors were located throughout the school and were more accessible to students than the offices of the other three members of the pupil personnel services.

The pupils' understanding of the school counselor seemed to grow with the length of time the students spent at Thomas Jefferson Junior High School—the third year student having the best understanding. The use of the school counselor seemed rather low when one considers the fact that only 24 per cent of the total sample said that they used the counselor. The researcher felt that a much higher percentage of understanding would definitely increase the use. Perhaps many of the students who answered negatively on understanding were the very students who needed to use the counselor. The benefit correlated very closely with the use except in the case of first year students. In this case, the benefit was much higher than the use and perhaps this can be explained by the fact that the counselors met the first year students on orientation day and even though this was not a conference or

counseling session, the first year students reflected this in their answer to item number eleven on the questionnaire.

One thing that probably helped the nurse's rating was her title. Most students would have some understanding of her role just because they are familiar with nurses. The very low use and benefit of the school nurse might be explained by the fact that state law keeps her from actually treating students. She has authority only to advise, diagnose communicable diseases, study health records, and check weight, height and eyes. She spends only one-half day a week at Thomas Jefferson Junior High School.

Little use of the school psychologist was indicated in the responses. Probably this was because he can work only with students who have submitted signed parental permission slips and then his function is simply diagnostic in value. He is not allowed to treat any student. He comes to the school when he is called, and since he serves four schools, his appointments usually must be scheduled well in advance.

The visiting teacher was the least understood of the four members investigated, and as would have been expected with reference to his use and benefit, his rating was very low in these areas. Some probable reasons for such a low evaluation are: (1) he comes to the school only once a week; (2) he works only with students who have attendance problems; (3) he works with several other schools and therefore has a limited amount of time to give to Thomas Jefferson Junior High School students.


An examination of the responses to all four positions has led the researcher to feel that there is a strong need for a much improved orientation program on a continuing basis for all the pupil personnel services at Thomas Jefferson Junior High School. In all instances except in the area of understanding of the role of the counselor and nurse the "no" answers are greater than the "yes" answers. 14 In the areas of use and benefit for all of the pupil personnel services, the researcher found the negative answers to be greater than 66 per cent. The lack of understanding was further emphasized by the list of negative comments that was compiled. 16 These comments seemed to indicate a strong need for better understanding of the total pupil personnel services.

Some other recommendations are: (1) move the offices of school psychologist, school nurse, and visiting teacher to locations that are more accessible to students; (2) reevaluate the job description of the school psychologist and try to improve the procedure for seeing him.

In the final analysis it is safe to conclude that students will not avail themselves of the beneficial use of any of the pupil personnel staff until they understand and appreciate their functions. Orientation directed toward this end should facilitate such understanding.
